**Mission of the KSF;**

The Kosovo Security Force is an entirely volunteer force built from all strata of society. Mission of the Kosovo Security Force, as an instrument of security is provision of support to the Government of the Republic of Kosovo.

**The territory of scope:**

The members of the Kosovo Security Force may be engaged outside of the territorial borders of the Republic of Kosovo when they are invited to do so by international organizations whose member is or aspires to be the Republic of Kosovo or on a bilateral basis along members of these organizations and after ministerial authorization.

**Individual rights of the KSF personnel:**

To the KSF members is provided fair and equal treatment regardless of gender or ethnicity, the chance to have a full career and fully realize their potential through the practice of appointment, promotion to the duty and development based on general system of merit and transparency.

**Competition Criteria;**

- To be an active member of the KSF with rank Lieutenant Colonel (OF-4) and above;
- To have knowledge of the English language at the level of STANAG III;
- To pass the verification process that is needed;
- Should not have been a subject of any violation disciplinary measure
- To have reached great results in annual performance report

**Duration of Appointment**

- The mandate of Defense Attaché is 4 (four) years, with a possibility of extension for 1 (one) year in the same country, if this mandate is not terminated earlier.
- The appointment of defense attaché for the second mandate in other countries is done by going through selection procedures based on the evaluation and needs of the MKSF and KSF. After completion of the service the Defense Attaché returns to the previous job position by regaining the status they had or to an equivalent position.

**Application Deadline;**

- The vacancy announcement is opened dated **04.01.2018** until **11.01.2018**.

**How to apply;**

Applicants shall fill out the application form and sign it and, then the application form shall be submitted to Personnel Office of Unit in person, every working day from 09:00-15:00h until the deadline of the announcement. Application forms will be available at the Personnel Offices in the KSF units, where vacancy is announced. Candidates may attach copies of documents / certificates / degrees recently obtained and which are not recorded yet in their personal file.
